

# **WALWORTH COUNTY FAIR WAIVER & RELEASE OF LIABILITY (YOUTH 17 & under)**

## **EQUINE ACTIVITY LIABILITY ACT**

Under the Equine Activity Liability Act, each participant who engages in an equine activity expressly assumes the risks of engaging in and legal responsibility for injury, loss or damage to person or property resulting from the risk of equine activities.

### **OTHER IMPORTANT INFORMATION**

1. Walworth County Fair or its members are not responsible for any accidents, injuries, loss or damage of property concerning person or horse under the Equine Activity Liability Act.
2. Walworth County Fair is not responsible for accidents or theft to people or vehicles.
3. Riders ride at their own risk.
4. All Walworth County Fair rules must be followed.
5. Each rider (including alternates) must complete a waiver and provide to Walworth CF personnel prior to the event.

I agree to hold harmless, Walworth County Fair, its members, employees and agents from all liability for any personal injury, which may result from my participation in the Walworth County Fair Drill Team Competition.
